ISP Submission

- M/s Indothai Airport Management Services Private Limited was selected through a bidding process
 for provision of Ground Handling Services at the Navi Mumbai International Airport by the Airport
 Operator i.e., M/s Navi Mumbai International Airport Private Limited (NMIAL). M/s Indothai
 Airport Management Services Private Limited (successful bidder) has incorporated a new
 subsidiary company i.e. M/s AGHPort Aviation Services Private Limited as the Service Provider
 for providing Ground Handling Services (GHS) at the Navi Mumbai International Airport.
- 2. M/s AGHPort Aviation Services Private Limited, the Independent Service Provider (ISP), vide its letter dated 08.08.2025 requested the Authority to approve the ad-hoc tariff in respect of Ground Handling Services (GHS) to be provided at Navi Mumbai International Airport, based on the Tariff for Ground Handling Services in respect of Mumbai Airport already approved by AERA, till the determination of regular Tariff for the ISP by AERA.
- 3. M/s AGHPort Aviation Services Private Limited in its submission for approval of Ad hoc Tariff has submitted the copies of following documents: -
 - (i) Letter of Award (LOA) no. NMIAL/INDOTHAI/PRJ/0480 dated 17.03.2025 issued by NMIAL for undertaking Ground Handling Services at the Navi Mumbai International Airport.
 - (ii) Certificate of Incorporation of M/s AGHPort Aviation Services Private Limited dated 22.04.2025.
 - (iii) Ground Handling Service Agreement executed on 23.05.2025 between the Airport Operator (NMIAL) and M/s AGHPort Aviation Services Private Limited.
- 4. Subsequently, the ISP vide email dated 22.09.2025 submitted a copy of security clearance granted by BCAS vide its letter no. CAS (M)-2025/Esahaj/NMIAL/Aux/M/s AGHPort/F-01(E-274767) dated 22.09.2025 in favour to AGHPort Aviation Services Private Limited for GHS at Navi Mumbai International Airport, valid for 5 years from the date of issuance of security clearance.

Authority's Examination

- 5. The Authority notes that M/s AGHPort Aviation Services Private Limited has executed a License Agreement with Airport Operator (NMIAL) on 23.05.2025 for providing Ground Handling Services at Navi Mumbai International Airport for a period of ten years.
- 6. It has been noted that the ISP has received security clearance by BCAS, vide its letter dated 22.09.2025. The Security clearance granted by BCAS is valid for a period of 5 years from the date of issuance of security clearance.
- 7. The Authority, after having examined the submission of the M/s AGHPort Aviation Services Private Limited regarding approval of tariff for their proposed ground handling operations at Navi Mumbai airport, is of the view that it will take some time for ISP to submit the MYTP (in respect of the ground handling services at Navi Mumbai airport) and completion of due regulatory process for the determination of regular tariff for the service provider.
- 8. Meanwhile, in order to enable the ISP to commence commercial operations at Navi Mumbai airport, the Authority, as an interim measure, decides to consider the ad-hoc Tariff for the ISP in respect of its proposed Ground Handling Services, based on the analysis of the tariff of GHS approved by AERA earlier at other comparable airports viz. Noida, Mopa Goa and CSMIA, Mumbai Airports.

Regulatory Authority

The Authority has considered the competitive rates for GHS Services as an Ad-hoc Tariff for the ISP at Navi Mumbai airport, as per the Annexure I, II and III to this Order.

ORDER

- 9. Upon careful consideration of the submissions made by the ISP at para 1,2,3 and 4 above and the relevant material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:
- (i) M/s AGHPort Aviation Services Private Limited, is allowed to levy and collect charges for the Ground Handling Services at Navi Mumbai International Airport as per the Annexure-I, II & III, as an interim arrangement, effective from the Commercial Operation Date (COD) up to 31.03.2026, or, till the determination of regular Tariff for the ISP, whichever is earlier.
- (ii) The Authority decides that the Tariff(s) for the Domestic 'Non-Scheduled & General Aviation Flights' shall not exceed the approved Tariff(s) for the relevant Domestic Scheduled Flights for similar class of aircraft(s).
- (iii) Tariff approved, as above, shall be the maximum charges to be levied to users. No other charge(s) is to be levied over and above the approved Tariff.
- (iv) M/s AGHPort Aviation Services Private Limited shall ensure compliance of Standardization of Ground Handling Equipment at Navi Mumbai International Airport, in accordance with the directives issued by the Ministry of Civil Aviation vide letter no. AV-24011/10/2021-AAI-MOCA dated 27.10.2022.
- (v) The Tariff approved hereinunder is excluding of applicable taxes.
- (vi) The Airport Operator shall publish the approved Tariff for M/s AGHPort Aviation Services Private Limited at Navi Mumbai International Airport at its official website for the information of all Stakeholders.
- (vii) The Airport Operator shall ensure compliance of this Order.
