Sub: Ad-hoc Tariff for M/s Air India SATS Airport Services Private Limited (AISATS) for its proposed Ground Handling Services at Cochin International Airport, effective from Commencement Operation Date (C.O.D.) to 31.03.2026 - Reg.

Background and Independent Service Provider's submission:

- M/s Celebi Airport Services India Private Limited (Celebi) was providing Ground Handling Services at Cochin International Airport since January, 2018. AERA, vide Order no. 24/2021-25 dated 14.10.2021 had approved tariff in respect of the Ground Handling Services (GHS) for the Third Control Period (FY 2021-22 to FY 2025-26) w.e.f. from 01.11.2021 to 21.03.2026.
- Bureau of Civil Aviation Security (BCAS), vide letter dated 15.05.2025 had withdrawn the security clearance of M/s Celebi on the ground of national security.

- 3. M/s Air India SATS Airport Services Private Limited (AISATS) vide letter dated 08.10.2025 informed that M/s Cochin International Airport Limited, CIAL (Airport Operator) had issued a tender on 10.07.2024 for appointment of two new Ground Handling Agencies (GHA) at Cochin International Airport, in place of existing Ground Handling Agencies (M/s Celebi and M/s Bird Worldwide Flight Services (India) Private Limited) whose regular concession term had ended and were operating on ad-hoc extension given by the Airport Operator, as AERA approved tariff rates was valid upto 31.03.2026.
- In the aforesaid tender, M/s AISATS emerged as a successful bidder and the Airport Operator issued for Letter of Intent to Award dated 04.06.2025 the Concession for providing Ground Handling services at Cochin International Airport.
- Subsequently, a Concession Agreement dated 01.08.2025 was executed between the M/s AISATS
 and M/s CIAL for a period of 5 years, effective from the date of C.O.D., which may be extended
 for further period of 2 years.
- 6. M/s AISATS, the Independent Service Provider (ISP) in its letter dated 08.10.2025 requested the Authority to approve the Ad-hoc Tariff in respect of its proposed Ground Handling Services at Cochin International Airport, based on the tariff rates (for FY 2025-26) that were earlier approved by AERA vide Order no. 24/2021-25 dated 14.10.2021 for the erstwhile Ground Handling Agency (M/s Celebi), with adjustment for the increase in Concession Fee payable by M/s AISATS to M/s CIAL as per concession agreement.

In this regard, the ISP has submitted the copies of the following documents:

- (i) Letter of Intent to award (LOIA) dated 04.06.2025 for appointment of M/s AISATS as second Ground Handling Agency at Cochin International Airport;
- (ii) Concession Agreement between M/s CIAL and M/s AISATS executed on 01.08.2025; and
- (iii) Rate Card for Ad-hoc Tariff in respect of proposed ground handling services.

Authority's Examination of the request of M/s AISATS for the approval of the Ad-hoc Tariff pertaining to Ground Handling Services:

- 7. The Authority notes that after the revocation of security clearance of the erstwhile ground handling agency (M/s Celebi) by BCAS, the airport operator (M/s CIAL) terminated its agreement with the erstwhile G.H.A. The airport operator, in order to ensure the continuity of ground handling services at Cochin International Airport, floated a tender for appointment of second and third ground handling agency, in which M/s AISATS emerged as a successful bidder.
- The Airport Operator issued letter of Intent to Award dated 04.06.2025 in favour of M/s AISATS
 and subsequently the concession agreement for the provision of the Ground Handling services at
 Cochin International Airport had been executed between the airport operator and the ISP on
 01.08.2025.
- 9. M/s AISATS, vide letter dated 08.10.2025 submitted interim tariff for its proposed ground handling services, based on the tariff rates (FY 2025-26) earlier approved by AERA for M/s Celebi (erstwhile GHA) increased to the extent of increase in Concession Fee applicable to the ISP vis-à-vis erstwhile GHA. It is noted that concession fee @ 48% of Gross Revenue (for FY 2025-26) was earlier payable by the erstwhile G.H.A to the Airport Operator, which as per the new Concession

Agreement (between M/s AISATS and M/s CIAL) is 20% for Domestic Flights and 64,15% for International Flights.

The Authority notes that M/s AISATS in its proposal for interim tariff, has factored-in the impact of increase in Concession Fee (as per its concession agreement) vis-à-vis the Concession Fee (FY 2025-26) that was applicable to erstwhile GHA, as an add on, in its proposed interim tariff.

- 10. The Authority sought the details Security Clearance granted by BCAS from the ISP. In response thereto, ISP vide email dated 24.10.2025 submitted the copy of Security Clearance granted by BCAS vide its letter dated 11.09.2025. The security clearance granted by BCAS in favour of M/s AISATS is valid for a period for 5 years from the date of issue of the letter, or, till the validity of the agreement with the Airport Operator, whichever is earlier.
- 11. After having examined the request of M/s AISATS, as per the Authority, it will take some time for the ISP to submit its Multi Year Tariff Proposal (MYTP) for determination of regular Tariff for Ground Handling Services at Cochin International Airport. In the interim, the Authority decides to consider an ad-hoc tariff for the ISP to enable it to commence commercial operations at Cochin Airport.
- 12. For the purpose of deciding the ad-hoc tariff for the M/s AISATS, the Authority has compared the interim tariff as proposed by the ISP with the tariff for ground handling services applicable to other ground handling agency operating at Cochin Airport i.e., M/s Bird Flight Services Private Limited (BFS) and tariff prevailing for GHS at nearby airports (Trivandrum, Mangalore & MoPA, Goa).
 - After the comparative analysis of tariff proposed by the ISP with the tariff prevailing at Cochin and nearby airports for ground handling services, the Authority has finalized the lowest tariff for GHS in respect of M/s AISATS as per *Annexure I & II*, as an interim arrangement. The ad-hoc tariff decided by the Authority for the ISP shall be effective from the C.O.D. up to 31.03.2026.
- 13. M/s AISATS shall inform the Authority the actual date of commencement of Ground Handling Operations at Cochin airport and shall submit the MYTP in the prescribed format, along with necessary supporting documents, within two months of commencement of regular operations, for the determination of regular tariff.

ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s AISATS is permitted to levy and collect charges for the Ground Handling Services at Cochin International Airport, on ad-hoc basis, as per *Annexure (I & II)*, effective from the COD till 31.03.2026, or, till the determination of regular tariff for the ISP for its First Control Period, whichever is earlier.
- (ii) Tariff approved, hereinunder, shall be the maximum tariff to be levied to users. No other charge(s) is to be levied over and above the approved Tariff.
- (iii) For payment of ground handling charges in foreign currency, the RBI conversion rate as on the last day of the previous month will be applicable for the first fortnight and exchange rate as on 15th of the month will be applicable for the second fortnight.



- (iv) M/s AISATS shall ensure compliance of Standardization of Ground Handling Equipment at Cochin International Airport in accordance with the directives issued by the ministry of Civil Aviation vide letter no. AV-24011/10/2021-AAI-MOCA dated 01.11.2021.
- (v) The Airport Operators, shall publish this Ad-hoc Tariff for M/s AISATS at its official website for the information of all Stakeholders.
- (vi) The Tariff determined hereinunder is excluding of applicable taxes, if any.
- (vii) The Airport Operator shall ensure compliance of the Order.
