This has reference to the Consultation Paper no. 25/2023-24 on in the matter of determination of aeronautical tariff for Thiruvananthapuram International Airport, for the third control period (01.04.2022 - 31.03.2027)

We would like to submit our views with regard to the Fuel Hydrant System proposed at Thiruvananthapuram, and the Authority's view on the same mentioned at para 7.3.99 of the CP.

It is submitted that the fuel throughput of Thiruvananthapuram airport is double the fuel throughput of Mopa, Goa airport, and comparable to the throughput at Lucknow airport. Majority of the fuel throughput at Thiruvananthapuram is for International flights, where the fuel offtake is much higher than that for the domestic flights.

Considering that the Fuel Hydrant System has been approved at both Lucknow and Mopa airports, we are of the opinion that it would be in order to approve the Fuel Hydrant System at Thiruvananthapuram airport also, where the international flights are more.
