The Government of India in the Ministry of Civil Aviation has constituted the Selection Committee for the purpose of selecting Chairperson and other Members of AERA, under sub-section (1) of Section (5) of the Airports Economic Regulatory Authority of India Act, 2008.

1.	Scale of pay	Pay Band 'HAG' in the scale of Rs.67,000/- 79,000/- (annual increment @3%) [Pre-Revised]
2.	Terms and Conditions	The Member will be governed by the terms and the service conditions as per Section 4 and 6 of the Airports Economic Regulatory Authority of India Act, 2008 and Rules made thereunder. The Member shall be whole-time Member.
3.	Essential Qualification and Experience	<p>Persons of ability and integrity, having adequate knowledge of, and professional experience in, aviation, economics, law, commerce or consumer affairs may apply for the said post.</p> <p>Further, any person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than 3 years.</p> <p>For persons who are presently working or have retired from a Central Public Sector Undertaking or a Statutory Body, he should be working or should have retired at least as Executive Director or its equivalent in a Schedule 'A' CPSU/equivalent rank in Statutory Body.</p> <p>For all other persons, they should have at least 25 years of experience in the relevant field.</p>
4.	Tenure	The Member shall hold office for a term of upto five years from the date on which he enters upon his office or till he attains the age of 62 years, whichever is earlier.
